Resolution #7 of 2020 - Forming Water District #4 on Tupelo Trail

In the Matter of the Petition for the Establishment of a Water District in the Town of Lima, Livingston County, New York, to be known as the "Water District No. 4."

RESOLUTION AND ORDER TO ESTABLISH DISTRICT

(Pursuant to Town Law §209-e) Resolution #7 of 2020

WHEREAS, it is the intent of the Town of Lima to create Water District No. 4 to include all of the real property indicated in the final map, plan and report prepared by Clark Patterson Lee, dated June, 2020 and being styled "Map, Plan and Report for the Town of Lima Water District No. 4" (hereafter "Map, Plan and Report"), said real property being located in the Town of Lima, County of Livingston and State of New York; and

WHEREAS, the real property that will be included in the district is more particularly described in said Map, Plan and Report filed in the Lima Town Clerk's Office; and

WHEREAS, the Town of Lima Town Board (hereafter "Town Board"), acting on behalf of the Town of Lima Water District No. 4, having previously directed the Town Engineer to prepare a map, plan and report with respect to the proposed district, said direction being authorized by a resolution of the Town Board and said Map, Plan and Report being accepted by the Town Board by resolution that was adopted on August 4, 2020; and

WHEREAS, the Town Board has directed that the charges incurred for the Map, Plan and Report shall be a Town charge until such time as the district formation shall take place at which time they shall become a district charge; and

WHEREAS, the Map, Plan and Report was subsequently filed in the office of the Lima Town Clerk; and

WHEREAS, the Board having previously complied with the relevant provisions of SEQR; and

WHEREAS, the Town Board on September 1, 2020 adopted a Resolution and Order pursuant to Town Law §209-d which directed that a public hearing be held on October 6, 2020 to receive public comment relating to the possible adoption of a resolution to establish the Town of Lima Water District No. 4; and

WHEREAS, the notice of public hearing was properly published and posted pursuant to New York State Town Law §209-d; and

WHEREAS, the notice of public hearing contained all necessary information to comply with New York State Town Law §209-d; and

WHEREAS, a public hearing having been held on the 6th day of October, 2020 at 6:00 P.M. at the Lima Town Hall located at 7329 East Main Street, Lima, New York, with respect to the creation of the Town of Lima Water District No. 4 to include the property noted in the Map, Plan and Report and as more particularly described in the Map, Plan and Report on file at the Lima Town Clerk's Office, in the Town of Lima, County of Livingston and State of New York; and

WHEREAS, a copy of the Map, Plan and Report describing the proposed district boundaries, the improvements to be constructed therein and a detailed explanation of the estimated cost of hook-up fees and the cost to the typical property, as well as the boundaries of the entire Town of Lima Water District No. 4, was available for the public inspection at the Lima Town Clerk's Office prior to and at each of the public hearings referenced above and is attached hereto and made a part hereof; and

WHEREAS, the Board having given due consideration to the testimony and evidence given at the public hearing conducted on October 6, 2020; and

WHEREAS, the Map, Plan and Report calls for the installation of water main, valves, water services and one or more hydrants to service eight (8) homes within the Salerno Subdivision Tupelo Trail; and

WHEREAS, that the cost for the water delivery improvements that will serve the proposed Town of Lima Water District No. 4 will be entirely borne by the developer of the Salerno Subdivision Tupelo Trail as part of the development cost of such project; and be it further

WHEREAS, the anticipated cost to the typical property located within the Town of lima Water District No. 4 is estimated to be \$575.00, which includes no debt service for the costs associated with the improvements, but rather is comprised of quarterly water charges of \$45.00 per quarter for (\$180.00 annually), plus estimated annual water costs of \$394.20 (estimated based on historical usage of single-family residential units within the Town of approximately 180 gallons per day); and

WHEREAS, that the cost associated with connecting the individual homes within the proposed Town of Lima Water District No. 4 has been paid for by the developer of the Salerno Subdivision Tupelo Trail and shall not result in additional charges to the benefitted properties within said District; and

WHEREAS, adoption of this Resolution and Order shall be subject to permissive referendum pursuant to Article 7 of the New York State Town Law; and

WHEREAS, because the anticipated cost to the typical property located within the Town of Lima Water District No. 4 is estimated to be below that of the estimated cost computed by the New York State Comptroller for the creation of similar types of districts, the formation of the Town of Lima Water District No. 4 will not require approval of the New York State Comptroller's Office.

NOW THEREFORE, be it

RESOLVED and ORDERED by the Town Board of the Town of Lima as follows:

- 1. That the notice of public hearing for the October 6, 2020 public hearing was published and posted as required by law and was otherwise sufficient;
- 2. That all of the property and property owners within the proposed Water District No. 4 are benefited thereby;
- 4. That all of the property and property owners benefited by Water District No. 4 are included within the limits of the proposed district; and
- 5. That it is in the public interest to form the Town of Lima Water District No. 4 as set forth; and it is further

RESOLVED and ORDERED, that subject to permissive referendum pursuant to Article 7 of the New York State Town Law, the Town Board of the Town of Lima does hereby establish the Town of Lima Water District No. 4 as set forth in the Map, Plan and Report; and it is further

RESOLVED and ORDERED, that within ten (10) days after the adoption of this Resolution, the Town Clerk is directed to record a certified copy of this Resolution in the Livingston County Clerk's Office and shall file a certified copy to the New York State Department of Audit and Control.

Proposed Local Law

Attorney Campbell distributed a proposed local law to amend Chapter 250 Article III and Article IV of the zoning ordinance of the Town of Lima, specifically to modify one or more definitions in Section 250-9 of such chapter and to modify section 25-11 R. To add new permitted uses and uses permitted with a special use permit. Specifically, repeal the former definition of "agribusiness enterprise" and to entirely replace the same with a new definition which shall be as follows: A retail or wholesale enterprise providing services or products principally utilized in agricultural production or agriculturally related endeavors, operated by the owner of a farm or agricultural operation existing on the property, including sale and erection of structures used in support of agricultural operations or farms, agricultural equipment and agricultural equipment repairs, storage and shipping of crops, or providing for wholesale or retail sale of grain, fruit, produce, trees, shrubs, flowers or other products of agricultural operations, including the packaging and storage of raw and processed materials utilized in the operation of said enterprise. Such enterprises shall not employ more than three persons who are not residents of the premises on which the enterprise is located. Attorney Campbell stated he also included breweries and distilleries where wineries is entered in the code. The Board agreed and upon motion by Councilperson Carey to have Attorney Campbell submit said proposed local law to the County Planning Board for their feedback and approval as well as the Agricultural Advisor Board and Town Planning Board for comment, seconded by Councilperson Button, the vote went as follows:
